Evening Working (from 17:01 – 21:00 Monday to Thursday) – the applicable day rate for evening working is one and a half times (x1.5) the rate stated within the Stand Rate Card

Night Working (from 21:01 – 08:59 Monday to Thursday) – the applicable day rate for evening working is double (x2) the rate stated within the Stand Rate Card

Weekend Working (from 17:01 Friday to 08:59 Monday) - the applicable day rate for weekend working is double (x2) the rate stated within the Stand Rate Card

National Holiday Working - the applicable day rate for weekend working is double (x2) the rate stated within the Stand Rate Card

Offered Discounts - CDG is able to offer discounted day rates under certain conditions to ensure best value for money for any given service. This would be assessed on a case by case basis and would be in recognition of one or more of the following conditions - strategic importance of the service being undertaken, number of days purchased, financial value of expenditure and length of service.
