## 1. Compliance Centre Module pricing

We have extensive experience of implementing Risk Management software into a wide range of businesses. We find the key to successful adoption and usage of software is an outstanding on-boarding and setup service, combined with reliable, cost effective on-going support.

All Compliance Centre module pricing is based on a small Setup Fee (per module, one-off fee), plus an Annual Licence Fee, per module per year.

#### 1.1. Setup Fee

Our one-off Setup Fee of £495 includes:

- On-boarding of Compliance Centre Training module
- Base system configuration users, roles, organisational structure, permissions
- 2-hour webinar training session
- Implementation Management

The Setup Fee is payable upon contracting, and services will not commence until payment has been received in full.

#### 1.2. Annual Licence Fee

Each Compliance Centre module has an Annual Licence Fee of £7,500, which is the only ongoing cost required to keep using the service, once the initial Setup Fee has been paid.

The Annual Licence Fee of £7,500 per module includes:

- Use of the system for unlimited departments/locations
- 100 users
- Support (as detailed in our Service Definition document)
- Infrequent data extraction, in SSG format
- Maintenance & automatic updates

## 2. Optional extras

### 2.1. Additional training

#### 2.2. Data extraction

The maintenance and support of any bespoke development will be charged yearly and added to the Annual Licence Fee at 22.5% of the total development cost (including project management).

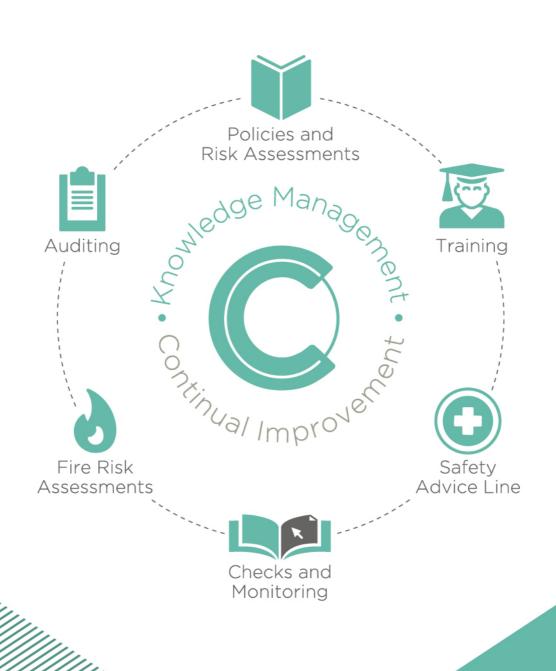
