An Overview of the GCloud Service

Cloud attendance provides actionable insight on attendance and room utilisation to Education and Local Government. Student Services, Timetabling and Estates teams can analyse student/staff engagement, while high-level overviews enable SLT members to drive down costs and improve student/staff satisfaction

Pricing

Pricing for Advanced Cloud Attendance is based on a number of factors: the size of the organisation (number of students), the modules required, the implementation services required, hardware required and the hosting options.

The price for a typical solution within a typical institution will be £1,329 per month.

This price includes licence, annual support and hosting.

Fees for on-boarding services are charged on implementation, at our submitted SFIA rates.

Additional Configuration

If further configuration is required outside the scope of the standard on-boarding service, the required number of days effort will be agreed on a case by case basis and will be charged at our submitted SFIA rates.

Minimum Contract period

The minimum contract period is for 24 months. Contract periods for longer than this are available, and can be discussed individually with the client

Trial Periods

Trial services are typically not available but can be arranged on an agreed case by case basis and will depend on the level of configuration required within the SaaS. Proofs of Concept are more commonly offered at an agreed fee without the requirement for a term contract.

The system is not typically offered on a “free of charge” basis.

Exit Costs

As long as a contract is terminated in line with the terms and conditions there is no specific costs for exiting the software. However where an organisation wishes to have some form of on-going access for historic purposes, after termination, an additional cost may be levied to provide such.
