## 1.1 AIS Service Description Summary

Cloudreach uses the following capabilities to deliver improvement services during business hours in a given month (together, an "AIS Pack"):

- Delivery of improvement services equivalent to one Improvement Engineer full time;
- Management of delivery of improvement services equivalent to one Improvement Lead available on a 25% basis;
- One Service Delivery Manager allocated to Customer

Delivery and management of improvement services will be delivered remotely, and where necessary up to 25% from Customer's premises in a given month, as mutually agreed between the parties. Further details are available <a href="https://example.com/here/">here</a>.

## 1.2 AIS Flex Service Description Summary

Cloudreach provides Customer with remote access to Improvement Engineers during business hours on an adhoc basis.

- One AIS Flex Units can be utilised with 1 (one) business day written notice, and;
- More than one AIS Flex Unit with 5 (five) business days written notice;
- Customer may request a maximum of 2 (two) AIS Flex Units per day

## 1.3 Agile Improvement Services Specific Terms

"Service Term" means unless stated otherwise, for the Agile Improvement Services, an initial period of [12] months from the Start Date (the "Initial Term"). The Service Term shall automatically renew for successive [1] month periods (each a "Renewal Term") unless terminated by either party



giving the other not less than 30 days prior written notice before the end of the Initial Term or each Renewal Term.

## 2. Cloud Core

On the Start Date, Cloudreach will charge Customer the Cloud Core Onboarding Charges set out in Table 1 as calculated in accordance with Table 1.1 Cloud Core Monthly Charges in Table 2 will apply as soon as Cloud Core has gone live. The service is live once monitoring and backups are activated as determined by Cloudreach.

For additional environments, Cloudreach shall charge the Customer the Cloud Core Onboarding Charges for the additional environment(s) and thereafter the Cloud Core Monthly Charges as soon as the additional environment(s) go live.

#### **Table 1.1 Cloud Core Onboarding Pricing Model**

**Components** = Configurable & Installable components within a customer environment. Examples: (Middleware, Instances, databases, load balancers etc.)

**Environments** = An environment is defined as a cloud account/subscription that serves a particular role such as Dev, Test, Pre-Prod or PROD OR a specific infrastructure stack (Database, app and web stack serving a website).

## 2.2 Cloud Core Monthly Charges

The Product Charges are in USD and the Customer agrees to pay Cloudreach in USD. If mutually agreed, Cloudreach may invoice Customer in a currency other than USD which may be subject to the Exchange Rate meaning the mid-market exchange rate as quoted by xe.com, on the date on which Cloudreach invoices Customer in accordance with this Product + 4%. For example if the quoted rate is 1 USD = 0.622886 GBP, then Cloudreach will exchange currency at a rate of 1 USD = 0.647801 GBP.

For the avoidance of doubt, the pricing structure in the table above is cumulative in nature as illustrated by the following examples:

**Example 1**: If Customer's AWS and/or Azure spend in a given month for the AWS and/or Azure Accounts set out in Appendix A is \$25,000, then the Customer's Cloud Core Charges shall be calculated as follows: \$10,000 \* 52% + \$15,000 \* 50% = \$12,700.

Notwithstanding the above, the Cloud Core Onboarding Charges shall not apply for any environment(s) that have been built by Cloudreach for Customer pursuant to a separate agreement between Cloudreach and Customer.

### 2.3 DevOps on Demand charges

DevOps on Demand should be used for a change, modification or creation of resources outside of the configuration of the environment from the time onboarding was completed, unless explicitly listed in the Standard Change list which will be provided upon request. The type of request or change for example are, creating new CloudFormation templates, updating Chef Cookbooks through to building new AWS or Azure resources.

## 2.4 Cloud Core Specific Terms

#### 2.4.1 Term

"Term" means unless stated otherwise, an initial period of 12 months from the Start Date (the "Initial Term"). The Term shall automatically renew for a successive 12 month period (each a "Renewal Term") unless terminated by either party giving the other no less than 30 days prior written notice before the end of the Initial Term or each Renewal Term. Customer shall have the right within the first 90 calendar days of the Initial Term (the "Appraisal Period") to terminate the Cloud Core service for convenience by providing 30 calendar days written notice prior to the end of the Appraisal Period.

### 2.4.2 Early Termination

In the event that this clause conflicts with any other terms this clause shall control, and with the exception of termination during the Appraisal Period, the Customer may terminate the service during the Initial Term or an Renewal Term.

The customer can do this by: (i) providing Cloudreach with 30 days' notice; and (ii) paying a sum equivalent to the average amount of Customer's previous monthly AWS or Azure spend multiplied by the number of months remaining of the Initial Term or Renewal Term as applicable.
