### Standards for Consultancy Day Rate cards

**Consultant's Working Day** – 8 hours exclusive of travel and lunch.

**Working Week** – Monday to Friday excluding national holidays.

**Office Hours** – 09:00 – 17:00 Monday to Friday.

**Note** – We will typically charge the day rates shown above for any calendar day, regardless of the actual hours worked. Where we frequently exceed 8 hours per calendar day, subject to giving the Customer reasonable prior notice, we would expect to be able to charge for all hours worked on a pro-rata basis.

**Travel and Subsistence** – As we are not within the M25, this is not Included in our day rate and is therefore payable at departments' standard T&S rates.

**Mileage** – As above.

**Professional Indemnity Insurance** – included in day rate.
