## 1. Costs to Deploy

### 1.1Summary Costs

These figures are negotiable and will vary between customers. We are also able to provide delivery management if required (costs for this are excluded from the table below).

### 2. Maintenance Charges

The assumption is that hosting will be on the customer's own infrastructure.

Please note, in the absence of any information on expected performance levels and user requirements, these charges are negotiable.

Our pricing is based not on user numbers, but on data volumes in terms of 'active events'.

Numbers of 'active' records will be established each month by counting the numbers of individual "event" records on the CRC Delius database that are not terminated. An "event" on CRC Delius is the record of an offender's charge, prosecution, sentencing and management.

An event may include any pre-sentence work that the CRC undertakes, the offender management of offenders and the provision of interventions to those offenders managed by the NPS. Note: an offender may have more than one event.

A terminated event is one that has a termination date recorded against it, or in the case of those offenders NOT being managed by the CRC, where the intervention for which the CRC is responsible, has been terminated.

Where multiple interventions are provided, the event will remain classified as 'active' until the final intervention has been terminated.

The number of active events will be monitored from the database each week and an average figure for each calendar month used to provide the costing metric for each CRC.
