G Cloud 11: Pricing Document

Collaborator

Collaborator pricing is based on the total amount the subscribing body spent on bought-in (invoiced) services (non-salary costs) during the previous full financial year. Subscription prices are tiered, according to the table below. The prices quoted are annual and are based on a contract for a 1 year subscription:

The subscriptions detailed in the table below give access to all 5 Markets.

Training:

The prices in the table above include one face to face (on client site) training session, plus up to 4 web training sessions throughout the course of the subscription.

Multiple Organisations:

Where multiple organisations procure Collaborator subscriptions as a group (via a single order), the subscriptions above are discounted as follows:

- 2 organisations – 10% discount off each subscription
- 3 to 50 organisations – 20% discount off each subscription
- 50 to 150 organisations – 50% discount off each subscription

Note that the terms of licence prohibit the sharing of the Collaborator service, or the data from it, with other organisations. A subscription is required for each public sector organisation that is served by a single shared services unit. Combined Authorities can purchase a subscription for their own use, but the terms of the licence prohibit the sharing of this licence with the individual councils that sit within the combined authority group.

Discounts for organisations that also subscribe to Illuminator

If a subscribing organisation already has an active paid subscription to Illuminator it is entitled to a 20% discount off the above price. If the subscribing organisation orders both Collaborator and Illuminator simultaneously, they are entitled to a 20% discount of the price of each service (both Collaborator and Illuminator).

Multiple Years:

The G-Cloud 11 framework permits the procurement of contracts up to 2 years in length. Subscriptions with a 2 year term attract a 10% discount off the annual prices in the table above.

Devolved Government/Public Sector Organisations outside England:

Collaborator currently includes data from the English Public Sector. It is possible to add contracts data from other organisations (e.g. Local Authorities and other Public Sector Organisations in Scotland and Wales). In these situations (a) the organisations being added into Collaborator must disclose suitable data to Porge (b) every organisation being added will incur an annual cost of £2,500 exc VAT (c) there is a minimum order charge of 75 organisations.
