Platform terms and conditions

A customer will either moved to a higher Tariff if their patient capacity is exceeded, or capped and unable to add extra patients.

Note that patient capacity is measured by patients that have an active service, not a record - so a patient on a 2 week PROM service, for example, only contributes the maximum patient capacity for 2 weeks.

For every additional increase in patient capacity of 1,000, Inhealthcare will include 25,000 SMS messages and 25,000 Call minutes to UK landlines / mobiles to be used by the above services.

Inhealthcare Toolkit

The Inhealthcare platform has a Software Developer Kit (SDK) which allows selected partners to develop digital health services using the Inhealthcare platform as the underlying infrastructure. As part of this contract Inhealthcare will provide the customer and any of its Inhealthcare approved third parties access to the SDK to build their own digital health services.

Inhealthcare will provide supporting documentation to support the use of its SDK and will provide reasonable assistance to third party organisations using the SDK.

For services developed using the SDK Inhealthcare will calculate the number of actions used by the service and from this calculate the number of total number of resource units used. The episode duration for all bespoke services is 28 days.

Whilst the service is operating, the platform measures the number of actions used by the service and some of the functioned used. Actions which have a resource Unit associated with them are detailed in the following table.
