Link Maker licences

There are separate licences to cover the two separate areas, adoption and commissioning.

LMS licences are made up of the following three elements

Scale fee

This is based on the average number of looked after children over the past 3 years and is priced per child in care of the authority.

Customer fee

The licence for every customer is subject to a set fee to cover financial process and administration. If separate parts of a service need to be invoiced separately, each will be counted as a separate customer and this fee added. The scale part of this fee can be split between these invoices as required.

Office fee

The office fee covers a single office under which users can register on the Link Maker site. For each additional office a set fee applies.



Adoption licence - pricing

This is priced, per year, according to the breakdown below.

Annual licence fee = £20,468.84 excluding VAT

A discretionary discount of up to 8% can be applied for a combined RAA licence for the initial year, providing all members of the RAA hold an existing Link Maker licence and that there is no gap in the provision of service.



Commissioning licence - pricing

Link maker can be used free of charge by both local authorities and placement providers. All staff can create user-accounts to identify and arrange individual placement for any number of children with in-house carers, within a closed framework or consortium arrangements or through national searches where necessary.

Commissioning support licence

For additional levels of assurance, an annual support licence can be purchased. This includes:

- A service level agreement specifying minimum levels of availability of the platform and minimum support response times.
- Support staff available 9-5 via telephone and email.
- Prioritised development items (where this fits with the functioning of the wider platform)

Commissioning full licence

- System alerts available via SMS (in addition to email)
- The ability to create automatic schedules for referrals, e.g. by tiers or lots
