- The fees outlined in this document do include any additional license fees that may be levied by the relevant e-requesting system provider
- Implementation fees are a one-time fee per HIS or Oder Comms instance
- Volume = total provider volume, regardless of how much is routed through OrderWise
- Implementation Fee Includes OrderWise installation, configuration, integration, project management support and training support
- For on-premise solutions, customer is responsible for providing servers per MedCurrent's minimum technical specifications
- License fees include annual technical support
- All OrderWise licenses include 2 OrderWise instances (test and production)
- License fees are subject to review if volume growth exceeds 15% over current tier
