• Harassment & Discrimination Bot

Description:

Allows staff to develop their story around an incident anonymously in a safe environment. Available on any messaging channel and in any language, the bot gives people a way to go through their own discovery process to build their story. This may ultimately a) turn into a complaint, b) end with no further action or c) lead to counselling or another outcome as may be defined.
