1. Pricing

1.1 Standard Feature Pricing

Pricing is based on per user per month, with a minimum of 12 months and 1,000 users.

1.2 Service Plan Pricing

The following table demonstrates how the costs of the service vary according to the volumes of users, the model assumes the customer will use their own existing Licensing for the service, Atos can provide licenses but this will impact the price of the service.
