2. Training

Training requirements are minimal due to the intuitiveness and simplicity of the product and as such all training is invariably conducted in virtual training sessions via WebEx. However, on-site training can be arranged at the Customer's request chargeable at charged at £1199 (where applicable) per day plus reasonable expenses.

3. Payment Protection

NECS reserves the right to claim interest from the customer under the Late Payment of Commercial Debts (Interest) Act 1998 at the current rate in force from time to time (before as well as after judgement) in respect of the late payment of any sum properly due. If the Late Payment of Commercial Debts (Interest) Act 1998 does not apply, NECS shall, at its sole option, be entitled to claim interest on any overdue sum at the rate of 4% per annum above the base rate from time to time of Lloyds TSB Bank PLC from the due date of payment until payment in full is made and whether before or after judgement.

Without prejudice to any other remedy available to NECS, in the event of any failure by the customer to pay any sum due to NECS by the due date for payment or if the customer shall be in breach of any of its obligations, NECS shall be entitled to suspend access to the RTT Project Outcomes (and therefore suspend the licence granted, as in the Terms and Conditions document), or suspend any services provided by it, until payment in full is made to NECS.

In the event that any suspension of access to the RTT Project Outcomes or suspension of services under Clause 2.2 lasts for a period in excess of thirty (30) days, NECS shall be entitled at its sole option to terminate access to the RTT Project Outcomes system without any further liability on NECS' part.
