## **Pricing Information**

All prices exclude VAT.

The following prices assume a minimum contract term of 12 months. For contracts less than 12 months in duration a 5% surcharge applies.

## **Entry-level system**

#### Setup charges

For the entry-level system the price for initial loading of the data is £1000.00, including provision of a basic Linked Data API configuration and redirection from the web domain of the client's choosing.

#### Monthly charges

The monthly charge for the entry level system is £500/month. This provides for the storage of up to 10 million triples and bandwidth of 10Gb/month. If these limits need to be exceeded then you will need to upgrade to the full platform.

## **Complete Fixed System**

## Setup charges

The price for the initial loading of the data is £1500.00. This includes the provision of a basic Linked Data API configuration, and a minimally branded landing page, and redirection from the web domain of the client's choosing.

## Monthly charges (full system)

The basic monthly fee for using the publishing platform is £800/month. This provides for the storage of up to 60 million triples and bandwidth of 20Gb/month. We charge an extra £500/month for each additional 50 million triples, and an extra £100/month for each extra 10Gb/month.

## Flexible System

The flexible system is intended to cater for a wide variety of customers with very different requirements. The pricing structure for this variant is therefore designed in a very modular fashion, to avoid penalising customers who want a specific combination of options by forcing them to pay for ones they don't want.



In particular, therefore, we treat the underlying hosting charges as **expenses**. We pay these hosting costs on the customer's behalf, and pass them on to the customer with no mark-up except for the addition of VAT). This means that customers who don't need high performance servers underlying their system do not need to pay for them. It also supports customers who need short term scale-up of their infrastructure to cope with particular events.

#### Setup charges

The price for initial loading of the data is £1500.00, including provision of a basic Linked Data API configuration and redirection from the web domain of the client's choosing. In addition, set-up charges may include (as expenses) reserved instance fees for any servers used.

#### Monthly charges

The monthly charge is £1000.00/month, plus any AWS charges as expenses. This does not include support charges for any major customisations, which will be charged via our Linked Data Publishing service.

#### Optional charges

Data conversion, data update automation, integration with existing workflows: these require the use of components of our proprietary Data Management System for which we charge an annual licence fee of £4,000.00.

URI reverse proxy service: This has an associated set up cost of £5,000.00 and a monthly support cost of £500.00, plus any additional AWS charges as expenses.

Typically customers of this variant also use our Linked Data Publishing service where we can provide effort to configure the various options e.g. to carry out initial data modelling if necessary, to develop data conversion and update automation scripts, to provide custom data presentation layers and to provide additional support options.

## Termination charges

There are no termination charges associated with the service. All client data will be securely deleted at the end of the contract term.

## **Payment terms**

We will invoice you for the set up costs on signature of contract. We will invoice you for the use of the service monthly in advance, with the first invoice being issued when the system goes live.

We expect payment of our invoices within 30 days.
