## **Pricing**

Pricing based upon a minimum annual subscription of £7,400\* per Local Authority area. Where the population exceeds 100,000 we charge £7,400\* per 100,000 head of population or percentage there of.

In addition, we charge a one off implementation fee per scheme of £10,500 plus VAT.

We apply a 33% pilot discount for year one.
